









Water Conservation

According to the World Water Development Report published by UNESCO in 2019, the improvement in water management and in safe access to water and sanitation has proven to be essential as a tool to eradicate poverty, build prosperous and peaceful societies and drive sustainable development.


In this context of the need to protect water as a vehicle for social development, Fundación Grupo Argos builds its model for the integrated management of water basins. Through knowledge and direct restorative actions, sustainable production and environmental education, this contributes with voluntary programs to the improvement of water quality and quantity conditions in three water basins. These basins have been prioritized according to the conditions of the regions where Cementos Argos, Celsia and Odinsa operate, specifically, in the basins of the Claro River in Antioquia, the Saldaña River in Tolima, and the Canal del Dique in Sucre, which have challenges in the water supply and quality.

Out of the 44,000 km³ of freshwater available per year on the planet. South America has 28% and Colombia has 5%; evidence of our country's water wealth. However, according to the latest version of the National Water Study published by the Ministry of Environment and Sustainable Development, 391 municipalities have been identified, distributed across 24 departments, that are susceptible to shortages; whether due to a reduction in the natural resources, climate variability or insufficient infrastructure.



Scholarships for Regional Developmen



Main Milestones of 2019

Each project of Fundación Grupo Argos is conceived and developed integrally in coordination with actors of the territory —essentially the beneficiary communities—, institutions and the partners of each program in order to launch coordinated actions of impact.

Main results of the water approach:

As a **restoration strategy**, in joint work with different actors, including Odinsa and Celsia and its ReverdeC program, in 2019, we planted around **465,000** trees of native species. Added to our efforts since 2016, these now amount to more than 2 million trees, which are added to the 4 million planted through ReverdeC in different parts of the country.

In 2019, we planted more than 465,000 trees of native species and we signed 97 conservation agreements with landowners.

In conservation and sustainable production in the year, we signed 97 agreements with landowners in Antioquia, Cauca, Tolima and Valle del Cauca. This enabled us to help protect the water sources and umbrella species, such as the Andean bear and the jaguar, cataloged as such because of their importance for the ecosystems' balance. With these agreements, we achieved the protection of more than 3,000 hectares of forest for a total of 8,000 hectares protected since 2017.

In the environmental awareness component, we worked with 174 educational facilities in eight departments of Colombia, where more than 48,000 children who participated in the Verde Vivo (Live Green) program study. The program aims to generate environmental awareness in the territory in order to promote the protection of water and harmonious relations with nature.

CUTTING-EDGE PRACTICES

The foundation worked on its strategic progress through a rigorous analysis accompanied by the Medellín Resilience Office on the best innovation practices in the world and topics of financing, management and governance, communication, education and conservation. The aim is to keep driving innovation as a pillar of the strategy that enables the application of cutting-edge solutions to empower the capacity of the projects to keep generating well-being.





Prioritization of Basins

The basins for intervention are established using a systemic method of analysis with a social and ecological approach developed by the foundation's team.

This method considers the main variables:







It is a model that has enabled us to develop aspects such as risk, quality, demand and governance of the water resource and to have a vision of the species and ecosystems at risk in Colombia. This result is compared with the prioritization of operations in the businesses of the Grupo Argos companies in order to focus intervention on the basins of the Rio Claro river in Antioquia, the Saldaña River in Tolima, and the Canal del Dique in Sucre.

Seven components have been considered for the implementation of these programs, in which actions are developed for conservation and social construction to protect the water resource and the health of the ecosystems, and to improve the communities' quality of life.



Objective: Generate scientific, academic and social knowledge for the creation of intervention models that entail local, national and international best practices and public policy.

Our work: Partnerships with environmental experts that enable us to generate useful knowledge in the assessment and comprehensive management of impacts on natural resources, and the publication of scientific reports and specialized reports.

COMPONENT: CONSERVATION

Objective: Contribute to water security. Our work: Projects to reforest and restore the ecosystems, protect water and biodiversity, and ensure sustainable production.

In 2020, we will continue with the Huella Viva (Living Footprint) program to conserve this important basin of the department of Antioquia and to help improve the quality of life of the communities that live in this territory.



In the conservation component, we planted 96,500 native tree species to protect the water sources and to strengthen the wildlife corridors. Similarly, considering variables such as replenishment, access to and quality of water, we identified around 207 potential plots of land and categorized 25 plots in the municipality of Sonsón, to make conservation and production agreements in the basin's area.

In the environmental awareness component, we worked in 22 prioritized areas, having an impact on 20,550 people, with whom we implement qualitative methodologies to identify their perceptions, environmental situations and dreams about the territory where they live. Similarly, we worked on the formation of environmental promotion committees, through which we have identified problems in waste management and deforestation.




Huella Viva Claro River, Antioquia



Social Innovation, **Citizen Actions for Social Development Award**

To end the year, the foundation delivered the Social Innovation, Citizen Actions for Social Development Award, an opportunity to create innovative initiatives for the solution of environmental and social problems that contribute to the businesses' risk management.

Forty-five volunteers participated from Barranguilla, Bogotá, Yumbo, Medellín, Barrancabermeia, Buenaventura and Calima del Darién, who presented proposals to resolve problems regarding waste collection, the reduction of plastic in water sources, the recovery of green areas and water conserva-

After the evaluation of the proposals by a world-class set of judges, three initiatives were awarded:

- Generation of partnerships for the use of food products that are not consumed in El Dorado International Airport in Bogotá, developed by employees in Odinsa-Opain
- Reuse of plastic to prevent it polluting the sea, presented by employees of Celsia in Buenaventura
- Raising tourists' awareness of the importance of separating waste at the source, developed by employees from Celsia in Calima del Darién



Our Action LINES OF WORK

We aim to transform this area in the center of Medellín, building new ways of inhabiting and sharing the public space.

To achieve this, at the Company with the partner companies, we prepared a proposal of comprehensive intervention in the heritage area of San Ignacio and its area of influence, which amounts to 61 blocks, where cultural and artistic vocations meet with the heritage and an important educational offer.

 Cultural strategy which aims to strengthen art and heritage through assistance and coordination of experience to attract residents and visitors

- Urban intervention to support the adaption of the public area and the improvement of living conditions
- Sustainable reinhabitation proposal for social and economic integration


