

RELEVANT INFORMATION



Grupo Argos, parent company with sustainable investments in infrastructure, reported a 23% increase in its consolidated revenue at the end Q3 2015, mainly due to the positive results in the cement business, the incorporation of the Central American operations into the energy business, good performance in the port business and solid business dynamics in the other lines of business.

The Company acquired an additional package of Odinsa stock, equivalent to 4.95%, in the third quarter. Through said acquisition, Grupo Argos now owns a controlling share of 54.8% in Odinsa, and it will continue supporting the company's local and regional growth and expansion strategy.

On the other hand and with the objective of supporting growth while increasing financial flexibility, in August Grupo Argos sold 5.3% of its stock in Cementos Argos for nearly COP 600 billion. Grupo Argos conserves its position of control in Cementos Argos, holding 55.3% of the common shares.

In the quarter the company was recognized for two important achievements. First, Grupo Argos and its subsidiary Cementos Argos were listed for the third consecutive year on the Dow Jones Sustainability Index, which acknowledges best practices in the areas of economic, environmental and social sustainability of companies listed on the exchange. Second, the Colombian Securities Exchange renewed Grupo Argos's Issuer Recognition (IR) as well as that of its subsidiaries: Cementos Argos, Celsia and Odinsa. The objective of this recognition is to honor the achievement of issuers complying with the highest standards of corporate governance.

Main results at the end of the first semester of 2015:

- Revenue was reported at COP 8.7 trillion, up 23% over the same period of 2014. This increase was due to positive results in the cement business, the incorporation of energy business operations in Panama and Costa Rica and the sale of a stock package in Cementos Argos.
- Year-to-date EBITDA for the period is COP 2.1 trillion, increasing 6% compared to 2014.
- Consolidated net profit was reported at COP 376 billion, compared to COP 678 billion in 2014. It was affected by the COP 105 billion paid for the equity tax and by the increase in financial costs associated with financing to acquire the Vulcan Plant for Cementos Argos, energy generation assets in Panama and Costa Rica for Celsia and additional Grupo Argos ownership in Odinsa.

- Assets are reported at COP 40.1 trillion, increasing 15%.
- Liabilities are reported at COP 17.8 trillion and equity at COP 22.3 trillion.

Main events for the businesses:

Cement – Argos

Consolidated revenue was COP 5.7 trillion, up 35%. EBITDA was reported at COP 1.1 trillion, up 41%. In Colombia, the company reported growth of 14% in cement volumes (compared to market average of 7.5%) and of 18% in concrete volumes (compared to market average of 9.2%), due to a general increase in volumes, especially in the north and northwest regions. The United States Region reported an increase of 19% in cement volumes and 5% in concrete shipments. Adverse weather conditions continue to affect concrete shipments in some southern states, primarily the Carolinas. In Central America cement volumes continue growing with force, achieving an increase of 19% in 2015, primarily driven by growth in Honduras and trading operations. Concrete shipments have been affected by lower consumption in Panama, and they are down 20% on the year. It is expected that several infrastructure projects will start back up in Panama in 2016, which should stimulate concrete consumption. Finally, the current exchange rate continues to benefit business results.

Energy - Celsia

Revenue was reported at COP 2.3 trillion, increasing 22% compared to September of 2014. This growth was largely due to consolidating operations in Central America. EBITDA of COP 566 billion was reported for a decrease of 25%. Effects of El Niño weather patterns, deficiencies in electricity transmission infrastructure in the Colombian Caribbean, the high exchange rate and variable market conditions affected business results. Startup of commercial operations at the Cucuana Hydroelectric Power Plant was an important achievement. This project represents an investment of approximately COP 335 billion and brings 55 MW of installed capacity.

Real Estate

Real estate business reported record sales in the third quarter at COP 47 billion. This growth was achieved as a result of registering the deeds for two lots with a total area of 15,250 m² in the Palmas del Río project and two more lots with an area of 47,100 m² in the Miramar project. In the rental property business, the transfer of assets to the new Pactia Trust continues on schedule, reporting 88% progress.

Ports

The business recorded revenue of COP 116 billion, up 28%. EBITDA was reported at COP 43 billion, up 61%. Bulk cargo business dynamics were positive this quarter, particularly at the Buenaventura and Tolú Terminals. We are also proud to announce that Compas and APM Terminals signed an agreement to improve and operate the Cartagena Port. This alliance includes a commitment to invest USD 200 million to expand port capacity.
