### 2. OVERVIEW

## 2.1. Purpose

The purpose of the Occupational Health and Safety Policy is to establish the guiding principles and guidelines on Occupational Health and Safety for Grupo Empresarial Argos.

### 2.2. Scope

Each of the companies will have its own policy that will be adjusted to the reality and needs of each of the organizations, however, all must respect the framework of this policy.

### 3. GUIDING PRINCIPLES AND GUIDELINES

Grupo Empresarial Argos is committed to protecting and promoting the health of its human talent, ensuring its integrity within the framework of a preventive culture that promotes self-care and the intervention of physical, biomechanical, psychosocial, biological, chemical and safety risks. As well as the maintenance of the Occupational Health and Safety Management System.

Senior Management is responsible for promoting a healthy and safe work environment, complying with the applicable legal requirements, maintaining a permanent and public commitment to continuous improvement, engaging stakeholders in the Occupational Health and Safety Management System and allocating the necessary human, technical and financial resources. In this sense, the company will promote the participation of all employees through all its channels and will rigorously monitor this participation.

In order to meet the above commitment, the company sets clear goals and a detailed action plan each year to achieve this objective within the framework of the current regulations for Occupational Health and Safety Management Systems.

All people, regardless of how they are hired, have a responsibility to comply with health and safety regulations and procedures, to perform safe and productive work with mutual care and self-care.
